A PROUD LEGACY OF INCLUSION

When the National Orchestral Association was founded in 1930, major American orchestras (including the New York Philharmonic) were comprised almost entirely of European-trained white males. To address this situation, the NOA's founding music director, Leon Barzin, decided to form a training orchestra that would permit students to play with outstanding international soloists at major venues like Carnegie Hall. Maestro Barzin auditioned all potential players behind a curtain so that only the talent and skill of the auditioner would be considered. The result was incredible. Unlike other orchestras at the time, the National Orchestral Association's symphony orchestra included talented women and African-Americans. Maestro Barzin believed that talent alone should be the sole criteria for admission to the ranks of any performing arts organization. Blind auditions facilitated the advancement of individuals who might otherwise not have opportunities to play with a major orchestra.

Maestro Barzin also pioneered efforts to bring music to inner-city students. When performing concerts at local public schools, Maestro Barzin would invite the students to come up to the stage to interact with performers and let them handle the musical instruments. Maestro Barzin stated that for many students, this was the first time they had actually seen or touched musical instruments. These in-school performances became a model for other organizations to bring music education to traditionally underserved communities. The National Orchestral Association is grateful for the rich legacy provided by Maestro Barzin's early efforts to make the symphony orchestra more inclusive.
